Mr. Sanderson announced that the Board met in executive session prior to the meeting. Mr. Clarke reported that during the executive session, the Board discussed several personnel matters and a matter involving the collective bargaining agreement. Mr. Sanderson informed the public that the Board intends to meet in executive session after this meeting and the Board will report on that at the next Board Meeting.

## <u>PENNSBURY SEA FALCONS SUBMERSIBLE AND APPLIED ENGINEERING AND</u> <u>TECHNOLOGY CLUBS RECOGNITION – DR. DUNAR</u>

Dr. Dunar welcomed members of the Submersible Sea Falcons and also the Prototyping Team along with their advisors, Mr. John Sanders, a teacher in Applied Engineering and Technology Education and Ms. Jessica Perfetto, Coordinator of Applied Engineering and Technology Department.

Mr. Sanders thanked Dr. Gretzula, the Board and the parents for support. Mr. Sanders shared that over the last five years the Pennsbury Sea Falcons Submersible Robotics Team have won more awards than any other high school team at the Sea Perch Competition. The Team participated in the annual National Sea Perch Competition at Temple University on March 18th sponsored by Temple University, the United States Navy and the Office of Naval Research. The PHS Team received commendation for their submitted notebook as well as three trophies: Spirit and Sportsmanship; Oral Presentation and Pool Performance.

# PENNSBURY SEA FALCONS SUBMERSIBLE AND APPLIED ENGINEERING AND TECHNOLOGY CLUBS RECOGNITION – DR. DUNAR (continued)

Ms. Perfetto proudly shared the project that the Applied Engineering and Technology Team planned to submit for the May 19<sup>th</sup> Competition. After researching concussion recovery, the Team developed a pair of interchangeable glasses with six therapeutic lenses that actually help filter out different types of light. Ms. Perfetto thanked the Board for their continued support.

The students introduced themselves and shared their plans after high school graduation.

The students thanked Mr. Sanders for being the "keystone" that holds the Pennsbury Sea Falcons Team together and presented him with a plaque officially ordaining him as the "Pennsbury Sea Falcons Fleet Admiral".

# EXCELLENCE AND EQUITY TASK FORCE UPDATE - DR. DUNAR

Dr. Dunar provided a brief update on the work of the Districtwide Task Force on Excellence and Equity. Dr. Dunar explained that this is a Districtwide team effort of administrators, principals, teachers and coordinators. Four subgroups of the Task Force were created to include: Hiring Practices; Expectations and Tracking; Curriculum and Instruction and Professional Development. Short term objectives include professional learning, developing curriculum, developing leadership and resilience in students and attending job fairs. Over the course of the next two years the Task Force plans to develop professional learning among our principals and teachers with plans to develop outreach with parents.

# 2017-2018 PROPOSED BUDGET PRESENTATION - MR. RODGERS

Mr. Rodgers outlined highlights of the budget schedule and discussed both the revenue budget as well as the expenditure budget. Mr. Rodgers also presented a budget comparison of the Preliminary Budget approved on February 9, 2017 and the Proposed Budget presented this evening to the Board for approval. The 2017-2018 Proposed Budget reflects the need for a 2.9% increase in the real estate tax rate. The 2017-2018 Act 1 Index for Pennsbury is 2.5%. Work continues to update and amend the Proposed Budget in preparation to present the Final Budget at the June 8, 2017 Board Meeting for final adoption.
